Her interest in social justice began as a child growing up in a family with a strong commitment to organized labor. Carolyn has served as Commissioner for Peace and Justice for Blessed Junipero Serra Regional Fraternity. Carolyn works in prison ministry at the San Mateo County Juvenile Detention Facility.
